PUBLIC NOTICE

The State Board of Professional Land Surveyors in accordance with 24 **Del.C.** §2706 (g) has proposed changes to its rules and regulations as mandated by S.B. 229, 74 **Del. Laws** c. 262. The proposal identifies crimes that are substantially related to the practice of land surveyors.

A public hearing will be held at 9:30 a.m. on January 20, 2005 in the Second Floor Conference Room A of the Cannon Building, 861 Silver Lake Boulevard, Dover, Delaware where members of the public can offer comments. Persons wishing to submit written comments may forward these to the Board at the above address. The final date to receive written comments will be at the public hearing.
